Sub: Meetings held by Hon'ble Labour Minister & EC members with EPFOA on cadre restructuring, deputationists & other issues – reg.

Madam/Sir,

At the outset, I, on behalf of the office bearers of EPFOA, would like to thank you for the enormous amount of extraordinary support shown by you towards the EPFOA during past few days. Your encouragement has empowered us to forcefully take up the issues of cadre restructuring & deputationists with management.

I would also like to brief you as to the efforts made by EPFOA during past week. I have issued a detailed representation to the Hon'ble Secretary (L&E) on 14.08.15 expressing strong dissent & condemnation by the EPF officers' community towards the DO letter dated 12.08.15 issued by the CPFC to Secretary (L&E) on the issue of deputationists in decision-making hierarchy of EPFO (a copy of said letter has already been circulated to all offices through email on 14.08.15).

Furthermore, I had separate meetings with Hon'ble CBT Members, Dr. G. Sanjeeva Reddy, Shri M. Jagadiswara Rao & Shri A.D. Nagpal wherein I briefed them on the long delayed issue of cadre restructuring as well as the newly resurrected issue of allowing deputationists at ACC-level in EPFO. The CBT members were sympathetic to the cause of EPF officers and assured that they will take them up with management. The CBT members also expressed their apprehensions regarding the deputationists issue. It has been learnt that they raised these issues during the 82nd EC meeting held at Delhi on 20.08.15, and certain assurances have been given to them, although details are awaited.

I would like to also intimate that the EPFOA sought & obtained an appointment with Hon'ble Labour Minister at Hyderabad on 20.08.15. The Hon'ble Minister was briefed, in detail, about the incomprehensible delay in cadre restructuring, viz. non-implementation of decisions of the 72nd EC meeting by EPFO as well as the violation of the time-limit of three weeks given by the Hon'ble Minister and another time-limit of 30.06.15 given by the Hon'ble Secretary to the Cadre Restructuring Committee to give its report. He was also intimated that, reportedly, the EC in its 82nd meeting held on 20.08.15 has once again extended the time limit for cadre restructuring by two months. The Hon'ble Minister was also briefed on the CPFC DO letter dated 12.08.15 on the deputationists issue and the strong dissent of EPFO officers in the matter. A reference was made to the numerous support letters received by the EPFOA from its constituent units during past few days and the Hon'ble Minster was apprised of the deep dissent & widespread discontent prevalent amongst the officers' community due to aforementioned ill-timed DO letter. I would also like to share that the Hon'ble Minister was briefed

about the ill-treatment, and the foul & obscene language used for EPFO officers,

including lady officers, in review meetings by senior most management. The EPF

Staff Federation members from Telangana were also present for the meeting with the

Hon'ble Minister. They too confirmed above facts to the Hon'ble Minister &

expressed their support for the issues raised by the Association.

The session with the Hon'ble Minister was interactive and he gave a very

patient hearing to EPFOA. He read the entire memorandum submitted by EPFOA

during the meeting itself. He was very positive towards above issues and

immediately issued directions to the Secretary (L&E) to examine the issues and

discuss them with him for their redressal.

It is hoped that the ministerial intervention may bring an end to the go-

around being given to the HR issues in EPFO.

Lastly, I wish to intimate to you that the Hon'ble Secretary (L&E) has kindly

consented to hold a meeting with EPFOA delegation on 27.08.15 at Delhi to discuss

the issues arising from CPFC DO letter dated 12.08.15 and EPFOA letter dated

14.08.15, both addressed to the Hon'ble Secretary (L&E). The EPFOA intends to

forcefully push for immediate implementation of cadre restructuring and also

submit our comprehensive opposition to the deputationists proposal in the

forthcoming meeting. I shall intimate the details of the meeting to you in due course.

In any event, I would like to once again assure you that EPFOA shall continue

its efforts to convert assurances into concrete results and to ensure an early & just

resolution to above issues. I would like to again thank you for your continuing

support and shall keep you updated of all the efforts made & progress achieved by

EPFOA in future.
