### **ANNOUNCEMENT OF THE OFFICE BEARERS AND CONSTITUTION OF THE CENTRAL EXECUTIVE**

#### **Election to the Central Executive Council — Term 2026-28**

Reference is invited to the Declaration of the Elected Members of the Central Executive and Directions for the Election of Office Bearers, No. EPFOA/Election/2026-28/07 dated 28.08.2026. In terms of para 3 thereof, the elected Members of the Central Executive met by video conference on 01.09.2026 and have communicated to the undersigned a consensus on the office-bearer posts of the Association, arrived at unanimously and without dissent and signed by all nine Members. The consensus having been reached and communicated within the time prescribed, no election by the General Body under para 5 of the said Order arises, and this order issues in advance of the dates indicated in para 6 thereof.

**2. Office bearers.** In terms of para 8 of Election Notification No. EPFOA/Election/2026-28/01 dated 12.08.2026, the following are announced as holding the office-bearer posts of the Association for the term 2026-28:

**3. Eligibility.** The minimum length of service in the Commissioner cadre prescribed by Article 8 of the Constitution for the posts of President, Working President, Secretary-General and Joint Secretary-General has been verified in each case, and each of the members named against those posts satisfies it.

**4. Co-option and Treasurer — taken on record.** At the same meeting, being the first meeting of the Central Executive after the election, the elected Members further resolved unanimously to

co-opt Smt. Ritu Kanojia in the Central Executive as the woman representative, and that she shall hold the office of Treasurer of the Association for the term 2026-28. Co-option under Article 7(3) and nomination of the Treasurer under Article 8(vi) are acts of the Central Executive in exercise of its own powers, and not of the Election Officer. They are accordingly taken on record.

**5. Constitution of the Central Executive.** The Central Executive of the Employees' Provident Fund Officers' Association for the term 2026-28, comprising the nine elected Members named at para 2 above and the member co-opted at para 4 above, is hereby constituted **with effect from 03.09.2026.**

**6. Conclusion.** The election to the Central Executive Council for the term 2026-28 stands concluded with this order. The record of the election will be handed over to the Secretary-General.
